

BlueCross BlueShield of Tennessee (BCBST) and Volunteer State Health Plan (VSHP) strive to keep network providers informed of important changes. Below, please see the content of our recent letter to network providers regarding 5010 implementation and enforcement:

In accordance with the guidance issued by our state and federal partners, BCBST and VSHP will implement version 5010 for all HIPAA X12 EDI claims transactions effective January 1, 2012.

Consistent with the guidance issued to all Managed Care Organizations in the TennCare program, claims that are not compliant with version 5010 will be rejected by **BlueCare/TennCareSelect** after January 1, 2012. Claims submitted on the CMS 1450 and CMS 1500 paper claim forms must include all required data elements as indicated in previous notifications.

Other than claims submitted to BlueCare/TennCareSelect, BCBST will continue to accept both 4010 and 5010 claims transactions until March 31, 2012. The ability to accept both 4010 and 5010 transactions for these claims, and these claims only, is the result of recent federal guidance permitting an enforcement delay until March 31, 2012. Again, the ability to accept 4010 transactions is only applicable to non-BlueCare/TennCareSelect claims.

Several major enhancements will occur for compliant 5010 claims submissions, including:

- Confirmation Reports will be replaced with the 277CA Claims Acknowledgment Transaction
- The 277CA Claims Acknowledgement will be returned within 2 hours of submission
- Creation of a web-based reporting tool for EDI claim reporting
- BCBST will utilize the 999 Transaction and the TAI
- BCBST will utilize EDIFECs for 5010 compliancy

In addition, BCBST launched a new HIPAA 5010 Compliance Self-Testing Web tool in July of this year. The free tool assists our providers and submitters in evaluating readiness for 5010 compliance. The HIPAA 5010 Compliance Self-Testing Web tool is open to all submitters and allows users to test de-identified 5010 files, and receive real time compliancy and detailed file analysis reports.
